- Provide effective support for colleagues;
- Work in close partnership with teachers / parents / carers to improve student outcomes;
- Keep abreast of current developments in Additional Educational Needs;
- > Contribute to the management of pupil behaviour;
- Contribute to the safeguarding, health and wellbeing of pupils;
- Provide administrative and organisational support for the Inclusion Manager.
- Consider the information that is shared with other stakeholders, ensuring that where necessary and appropriate, confidentiality is maintained.

SCOPE FOR IMPACT:

> Students with Additional Educational Needs should be able to reach their potential, as indicated by their target grade, in line with other students. This role is to provide the support and encouragement to those students in order to enable this to happen.
